2. Incomplete Documents will be rejected. It is in the interest of perspective applicant that they may inspect the proposed premises before submitting the bid.
3. DDCA has a requirement of meals –Food Boxes on Match days as under :

4. The vendors may quote separately for catering in the HILL-A and Old Clubhouse as per requirements given above. The vendor may quote for catering for both or one only i.e. for either of the HILL-A or Old Clubhouse.
5. Please note that the final requirements may have variation depending on the guidelines of BCCI / ICC. The exact requirement will be given 2 days before each match.
6. Food boxes will be vegetarian and vendors may suggest alternative menus along with costs.

7. The pouring rights are to be with Pepsico.
8. The vendor must ensure that beverages/package food is sold as per MRP.
9. The list of items to be sold along with their cost should be furnished in the Bid.
10. All Vendors will be responsible to obtain the health trade license from MCD.
11. The vendor will clearly mention the sum he agrees to pay in consideration for the grant of rights to sell the food items.
12. Only non-branded items will be sold as per the guidelines of BCCI. If any branded items is proposed to be sold, prior approval of DDCA will be necessary.
13. The applicant should be in the business of providing catering services-food boxes for a minimum period of three years as on 30th September, 2017.
14. All statutory taxes/fees of any kind shall be borne by the applicant.

Other Terms & Conditions:

- A. The necessary details / clarification if any can be obtained from DDCA Office.
- B. All quotations/ offers/ Tenders must be accompanied with D.D in favour of DDCA of 20% of the bid amount along with Pan No. / Tin No. / Service Tax Number and I.D Proof with company / Organisation/ Firm's details of Registration, Memorandum & Articles, Partnership / proprietorship details as the case may be. The said amount shall be retained by DDCA as an interest free security deposit.
- C. The payment for the services provided by the applicant shall be made within 30 working days after the conclusion of the final match.
- D. DDCA reserves its right to accept or reject any of the offers or cancel all offers and also modify conditions or effect any other change in items, terms and conditions.

- F. The quotation must reach the office of the DDCA by 23th October 2017 BY 4 P.M which will be opened on the same day at 4.30 PM.
- G. The Incomplete quotations in any manner or tenders not accompanied by 20% bid amount in the form of Demand Draft in favour of DDCA or lacking in any other respect will be summarily rejected.
- H. The incomplete quotations in any manner or lacking in any other respect will be summarily rejected.
- I. In the event another party is sought to be engaged as a supplier for the purposes of the tender, this may only be done by obtaining consent in writing of the Authorised official of DDCA.
- J. All disputes shall be subject to the jurisdiction of courts of Delhi.
- K. It is hereby clarified that all rights granted pursuant to the Tender are valid only for this match. No future rights are sought to be granted.
