1. Please read the Terms & Conditions carefully before filling up the document.
2. Incomplete Documents will be rejected. It is in the interest of perspective applicant that they may inspect the proposed premises before submitting the bid.
3. DDCA reserves the right to obtain feedback from the previous/present clients of the applicant and also depute its team(s) to inspect the site(s) at present contract(s) for on the spot first-hand information regarding the maintenance and other security related services provided by the applicant. The decision of the DDCA in this regard will be final and binding on all bidders.
4. Eligibility Conditions:-
 - a. The applicant should be in the business of supplying baggage scanners on hiring basis for a minimum period of two years as on September 30, 2017. The applicant should also ensure that all the scanners are installed and tested

one day prior to the match and should be in proper working condition throughout the match.

- b. The applicant shall ensure that the adequate technical support is available during the match.
5. DDCA has a minimum requirement of 3 big baggage scanners and 11 normal baggage scanners for the match days. That the successful will be required to install one [1] big scanner and one [1] normal size baggage scanner 48 hours before the commencement of the match. Please note that the final requirements might have slight variation depending on the security requirements of BCCI / ICC / Delhi police.
6. The applicant shall coordinate with all the concerned authorities.
7. The applicant shall ensure that all statutory compliances for its personnel are its responsibilities.
8. The rates should include the transportation, installation and removal of the baggage scanners.
9. All statutory taxes/fees of any kind shall be borne by the applicant.

Other Terms & Conditions:

- A. The necessary details / clarification if any can be obtained from DDCA Office.
- B. All quotations / offers/ Tenders should be on Company / Firms or Organisation Letter Head with logo.
