### **INSTRUCTIONS TO THE APPLICANT**

1. Please read the Terms & Conditions carefully before filling up the document.
2. Incomplete Documents will be rejected. It is in the interest of perspective applicant that they may inspect the proposed premises before submitting the bid.
3. DDCA reserves the right to obtain feedback from the previous/present clients of the applicant and also depute its team(s) to inspect the site(s) at present contract(s) for on the spot first-hand information regarding the maintenance and other

security related services provided by the applicant. The decision of the DDCA in this regard will be final and binding on all bidders.

4. Eligibility Conditions:-
  - a. The applicant should be in security services for a minimum period of three years as on 30<sup>th</sup> September, 2017.
  - b. The applicant shall ensure that the security personnel deployed are healthy and should be of minimum 21 years of age.
5. DDCA has a requirement of 150 security persons [including 20 women security guards] for the match on 1<sup>st</sup> November, 2017 and has further requirement of 100 security persons [including 20 women security guards] per day during the five day match to be held from 02<sup>nd</sup> December, 2017 to 06<sup>th</sup> December, 2017. Please note that the final requirements might have slight variation depending on the guidelines of BCCI / ICC and depending upon the order of Delhi Police. The persons shall include:
  - A) Ten [10] Supervisors with walkie-talkies for internal coordination.
  - B) One[1] Assignment Manager.
  - C) Security guards - male and female.
6. The timings of the test match to be held from 02<sup>nd</sup> December, 2017 to 06<sup>th</sup> December, 2017 are from 9am to 5 pm. Thus the guards have to be available from 7am to 7pm on the above mentioned days of the test match.
7. The applicant shall ensure that the entire stadium is protected at all times. They shall coordinate with all the concerned authorities to ensure the safety and security of the stadium.
8. The applicant shall ensure that all statutory compliances for its personnel are its responsibilities.
9. All statutory taxes/fees of any kind shall be borne by the applicant.

### **Other Terms & Conditions:**

- A. The necessary details / clarification if any can be obtained from DDCA Office.
- B. All quotations / offers/ Tenders should be on Company / Firms or Organisation Letter Head with logo.
- C. All quotations / offers/ Tenders must be accompanied with D.D of 10% of Bid amount along with Pan No. / Tin No. / Service Tax Number and I.D Proof with company / Organisation/ Firm's details of Registration, Memorandum & Articles, Partnership / proprietorship details as the case may be. The said 10% of the bid amount shall be retained by DDCA as an interest free security deposit.
- D. The payment for the services provided by the applicant shall be made within 30 working days after the conclusion of the match.
- E. DDCA reserves its right to accept or reject any of the offers or cancel all offers and also modify conditions or effect any other change in items, terms and conditions.
