2. Incomplete Documents will be rejected. It is in the interest of perspective applicant that they may inspect the proposed premises before submitting the bid.
3. DDCA reserves the right to obtain feedback from the previous/present clients of the applicant and also depute its team(s) to inspect the site(s) at present contract(s) for on the spot first-hand information regarding the maintenance and other walkie-talkie related services provided by the applicant. The decision of the DDCA in this regard will be final and binding on all bidders.

4. The applicant should be in the business of providing walkie-talkie services for a minimum period of two years as on 30th September, 2017.
5. DDCA has a minimum requirement of 110 walkie-talkies per day for the match days. Please note that the final requirements might have slight variation depending on the guidelines of BCCI / ICC.
6. The successful bidder shall be required to provide 10 walkie talkies one day prior to the commencement of the match days for T20 and five day test match. The successful bidder shall further be required to provide the remaining 100 walkie-talkies in fully operational mode at 9 am on 1st November, 2017 and at 7am during the match days for five day test match from 02nd December, 2017 to 6th December, 2017.
7. All statutory taxes/fees of any kind shall be borne by the applicant.

Other Terms & Conditions:

- A. The necessary details / clarification if any can be obtained from DDCA Office.
- B. All quotations / offers/ Tenders should be on Company / Firms or Organisation Letter Head with logo.
- C. The payment for the services provided by the applicant shall be made within 20 working days after the conclusion of the match.
- D. DDCA reserves its right to accept or reject any of the offers or cancel all offers and also modify conditions or effect any other change in items, terms and conditions.
