Introduction

1. The meeting began with a vote of thanks by the Ld. Administrator to all present for contributing their valuable time and expertise for the 'Cricket Affairs Committee'.
2. Mr. Sunil Valson and Ms. Amita Sharma were unable to attend the meeting due to prior commitments. The minutes were circulated to them and approved.

Suggestions by the Ld. Administrator

3. The Ld. Administrator laid out the role of the CAC in light of the forthcoming domestic cricketing season. The CAC will play a dual role of :

- a. Setting up the criteria, selection procedure, term, contracts and the remuneration for the Selectors (Senior & Junior Division), Coaches (Senior & Junior Division), Managers and the Support staff including Physiotherapist and trainers.
- b. Overseeing the DDCA League slated to begin by the September 2017.
- c. Preparing DDCA for the upcoming Domestic Cricket Season
- d. Framing of by-laws for the smooth and transparent organization of Cricket in DDCA.
- e. Suggestion reforms for the improvement of cricket in Delhi

4. It was decided that the applications will be called for the various posts. Contracts will be for a period of two years. Accordingly, the CAC laid down the following bare minimum qualifications for the various roles such as selectors, coaches, manager etc which is as follows:

MEN

Qualifications for Senior Selectors for Ranji/ Under 23

- a. International player or Cricketer who has played 50 first class matches
- b. Declaration to be provided as per the application form

Qualifications for Junior Selector - Under 19/ Under 16/Under 14

- a. International Player or cricketer who has played 35 first class matches
- b. Declaration to be provided as per the application form

Qualifications for Coach (Junior/Senior)

- a. International Player or 50 first class matches
- b. Level 2 Coaching preferable
- c. Experience of Coaching
- d. Declaration to be provided as per the application form
- e. The Applicant must mention their preference regarding the category they will like to coach.
- f. A presentation of the vision of the coach will be appreciated

Qualifications for Manager

- a. First class cricketer
- b. Corporate/Administrative experience will be preferred

Qualifications for Physiotherapist

Certified level one with an experience of handling any sports team

Qualifications for Trainer

Qualified NCA trainer with level one certificate

WOMEN

Qualifications for Senior Selectors for Senior/Under 23

- b. International player or Cricketer who has played 20 first class matches
- b. Declaration to be provided as per the application form

Qualifications for Junior Selector - Under 19/

International Player or cricketer who has played 20 first class matches

Declaration to be provided as per the application form

Qualifications for Coach (Junior/Senior)

- a. International Player or First class player
- b. Level 2 Coaching preferable
- c. Experience of Coaching
- d. Declaration to be provided as per the application form
- e. The Applicant must mention their preference regarding the category they would like to coach.
- f. A presentation of the vision of the coach will be appreciated

5. It was decided that like the previous year, selections shall take place by inviting CVs from prospective candidates followed by an interview. It was further decided that the advertisement inviting CVs shall be put up on the DDCA website by 7th August 2017. Last date for receipt of applications will be 15th August 2017. The CAC will be meeting on 21st August 2017 at a time to be communicated to the Applicants by 16th/17th August 2017.

6. It was unanimously agreed that the application procedure will be open to players/persons belonging to all states and applications shall be decided on merits, However, the members agreed that while selecting individuals preference would given to the Players belonging to the Delhi as they will be familiar with the nuances of cricket in Delhi.

Guidance by Committee Members for the organization of DDCA League

7. The Committee Members provided helpful suggestions regarding the format and conduct of the DDCA League. Shri Ashwin Krishnan, Incharge, Organization

Committee, DDCA League requested and invited the Committee Members to the next meeting of the DDCA Organization Committee to seek their guidance for organizing the DDCA League. The Committee Members assured their absolute cooperation.

8. The Committee Members agreed that a Video Analyst is an indispensable requirement for the team. It was pointed out that DDCA has 3 video analysts as employees and complete cooperation will be provided to the teams.

9. The meeting ended with a vote of thanks by the Ld. Administrator to the Committee Members for their kind support and cooperation.
