- 4. Material / items will be checked before using at site.
- 5. Eligibility Conditions:
 - a. The applicant should be in the business of providing CCTV security services for a minimum period of two years as on as on submission of tender.

- b. The applicant shall ensure that adequate technical support to ensure the smooth functioning of the CCTV cameras provided throughout the match.
- 5. DDCA has a minimum requirement of 104 CCTV cameras including 13 pole mounted(PTZ) motorised cameras for the match day. These shall be purely on hiring cum rental basis for the duration of the match. Installation and removal shall be part of the responsibility of the bidders. 6. **SCOPE OF WORK:**

- a. The vendor is required to coordinate with all the concerned authorities to ensure the safety and CCTV security of the stadium and surrounding areas.
- b. The cameras shall be HD/IP based technologies. Vendors may submit separate bids for HD and IP based solutions.
- c. Vendors shall be required to instal the cameras as per the requirement given by DDCA Security/ Delhi Police.
- d. The cameras shall be functional along with monitoring screens put up in the designated security control room setup in the stadium.
- e. Distance from security control room may go upto 1000 meters for certain cameras, hence suitable repeaters may be required to be installed by the vendors. Approximate locations of cameras is given as annexure to this tender.
- f. Exact location of the cameras shall be given to the vendors 10 days before the final date.
- g. All the systems should be functional by 10 March 2019.
- 7. The applicant shall ensure that all statutory compliances for its personnel are its responsibilities.
- 8. All statutory taxes/fees of any kind shall be borne by the applicant.
