#### SPECIAL CONDITIONS OF CONTRACT

- a. DDCA has requirement of 10 HHMDs for 3 days and 210 HHMDs for match day, 3<sup>rd</sup> November, 2019. Please note that the final requirements might have variation depending on the security requirements of BCCI / ICC / Delhi Police.
- b. Sample of HHMD shall be submitted with the bid. It shall be deposited with the Security Department of DDCA.
- c. HHMDs will be inspected by DDCA Security Department 96 hours before they are moved to the stadium for installation. HHMDs shall not be changed after they are inspected.
- d. HHMDs shall be mad available 12 hours before the deadlines given in the tender document.
- e. Contractor shall ensure replacement of any faulty HHMDs within 2 hours of their being identified. Contractor may keep adequate reserves at site.
- f. Maintenance team of 3 engineers to be stationed at FZK Stadium 6 hours before the match commences and stays till match is over.
- g. Names of maintenance team to be given to DDCA 10 days before the match to prepare their accreditation cards.
- h. The contractor shall collect all the HHMDs within 2 hours of match getting over. The security of HHMDs shall be responsibility of the contractor. The HHMDs shall be directly supplied to the Delhi Police personnel and collected back by the contractor. DDCA shall not be held responsible for any loss or damage to the HHMDs supplied by the contractor.
- i. The numbers are tentative. Exact number shall be informed before the match. Payment shall be made on exact number only,.
- j. The Bidder shall ensure that all statutory compliances for its personnel are its responsibilities.
- k. The rates should include the transportation, installation and removal of the HHMDs.
- I. All statutory taxes/fees of any kind shall be borne by the Bidder.

#### **INSTRUCTIONS TO THE BIDDER**

- 1. Please read the Terms & Conditions carefully before filling up the document.
- 2. Incomplete Documents will be rejected. It is in the interest of prospective Bidder that they may inspect the DDCA Premises / location.
- Material will be checked before using at site.
- 4. Eligibility Conditions:
  - a. The Bidder should be in the business of supplying HHMDs on hiring basis for a minimum period of three years as on date of submission of tender as per schedule/information given by DDCA.
  - b. The Bidder shall ensure that the adequate technical support is available during the match.
- 5. Each page of the tender should be signed by authorized signatory.
- 6. The sealed envelope should be dropped in the Tender Box.
- 7. The bidder shall coordinate with all concerned authorities.
- 8. The necessary details / clarification if any can be obtained from the Chief Security and Protocol Officer, DDCA Office between 11.30 AM to 3.00 PM on any working day.
- 9. All quotations / offers / Tenders should be on the firm given at Annexure 'X' with Company / Firms / Organization Stamp.
- 10. An Earnest Money Deposit (EMD) of 10% of quoted final cost in the form of Bank Draft shall be submitted by all bidders. The Bank Draft will be favouring Delhi & District Cricket Association payable at New Delhi. All quotations submitted without EMD shall be rejected.
