SPECIAL CONDITIONS OF CONTRACT

- a. DDCA has requirement of 10 DFMDs for 3 days and 100 DFMDs for match day, 3rd November, 2019. Please note that the final requirements might have variation depending on the security requirements of BCCI / ICC / Delhi Police.
- b. Contractor shall supply all Single Zone DFMDs.
- c. Sample of DFMD shall be submitted with the bid. It shall be deposited with the Security Department of DDCA.
- d. DFMDs will be inspected by DDCA Security Department 96 hours before they are moved to the stadium for installation. DFMDs shall not be changed after they are inspected.
- e. DFMDs shall be installed and made functional as per the date and time communicated by DDCA.
- f. Contractor shall ensure replacement of any faulty DFMD within 2 hours of their being identified. Contractor may keep adequate reserves at site.
- g. Maintenance team of 2 engineers to be stationed at FZK Stadium 4 hours before the match commences and stays till match is over.
- h. Names of maintenance team to be given to DDCA 10 days before the match to prepare their accreditation cards.
- i. The contractor shall remove all the DFMDs with 12 hours of match getting over.
- j. The security of DFMDs shall be responsibility of the contractor. DDCA shall not be held responsible for any loss or damage to the DFMDs supplied by the contractor.
- k. The numbers are tentative. Exact number shall be informed before the match. Payment shall be made on exact number only,.
- I. The Bidder shall ensure that all statutory compliances for its personnel are its responsibilities.
- m. The rates should include the transportation, installation and removal of the DFMDs.
- n. All statutory taxes/fees of any kind shall be borne by the Bidder.

- 2. Incomplete Documents will be rejected. It is in the interest of prospective Bidder that they may inspect the DDCA Premises / location.
- 3. Material will be checked before using at site.
- 4. Eligibility Conditions:
 - a. The Bidder should be in the business of supplying DFMDs on hiring basis for a minimum period of three years as on date of submission of tender as per schedule/information given by DDCA.
 - b. The Bidder shall ensure that the adequate technical support is available during the match.
- 5. Each page of the tender should be signed by authorized signatory.
- 6. The sealed envelope should be dropped in the Tender Box.
- 7. The bidder shall coordinate with all concerned authorities.
- 8. The necessary details / clarification if any can be obtained from the Chief Security and Protocol Officer, DDCA Office between 11.30 AM to 3.00 PM on any working day.
- 9. All quotations / offers / Tenders should be on the firm given at Annexure 'X' with Company / Firms / Organization Stamp.
- 10. An Earnest Money Deposit (EMD) of 10% of quoted final cost in the form of Bank Draft shall be submitted by all bidders. The Bank Draft will be favouring Delhi & District Cricket Association payable at New Delhi. All quotations submitted without EMD shall be rejected. EMD amount shall be refunded to unsuccessful Bidders within a week of opening the commercial bids. EMD shall be submitted by all bidders along with PAN No. / TAN No. / Service Tax Number and I.D.
