Dear All

I. On 11.04.2020, I have received an Application from DDCA wherein it is seeking modification of my Order dated 08.03.2020. Apart from this, various other issues related to DDCA have been pending, some of which are as follows:

1) As per my Order dated 08.03.2020, I had issued show-cause notice(s) to Mr. RajanManchanda and Mr. Maqsood Kareem on a Complaint filed by Disciplinary Committee. Said members were directed to file their reply by 31.03.2020.

2) As per my Order dated 15.03.2020, I had issued show cause notice to following members of Finance Committee and Infrastructure Committee:

- i. Mr. Sanjay Bhardwaj (Finance Committee & Infrastructure Committee)
- ii. Mr.Apurv Jain (Finance Committee & Infrastructure Committee)
- iii. Mr.Alok Mittal (Finance Committee & Infrastructure Committee)
- iv. Mr. S.N. Sharma (Finance Committee)
- v. Mr.Nitin Gupta (Infrastructure Committee)
- vi. Ms.Renu Khanna (Infrastructure Committee)

3) Issue regarding retirement of Directors and their election thereof.

4) Action to be taken for procurement of documents in furtherance of Forensic Audit which is to be carried out for FY – 2018-19 & 2019-20.

II. All the issues mentioned above were originally meant to be taken up on 31.03.2020, however due to the lockdown ordered by the Government amid Coronavirus pandemic, same could not take place. Looking at the present circumstances and considering that lockdown has been extended till 30.04.2020, it would not be possible to hold a physical hearing for a considerable time to come.
