SPECIAL CONDITIONS OF CONTRACT

- a. DDCA has requirement of 30 Walkie Talkie for 15 days and From 25th April to 08th May 2021. Please note that the final requirements might have variation depending on the security requirements of BCCI / ICC / Delhi Police.
- b. Contractor shall supply Walkie Talkie radios duly programmed as directed by DDCA Security Department. The contractor shall ensure that there is no interference of frequencies in the different nets programmed for individual groups.
- C. The Walkie talkie Radios shall have adequate range to cover the entire stadium and parking areas.
- d. The Walkie Talkie Radios shall have a battery life of at least 12 hours from the time they are switched on.'
- e. One sample of Walkie Talkie Radio shall be submitted with the bid. It shall be deposited with the Security Department of DDCA.
- f. Contractor shall be responsible for licence for the Walkie talkie radio. DDCA shall not be held responsible for any violations of any such rules.
- g. Walkie Talkie Radios will be inspected by DDCA Security Department 96 hours before they are moved to the stadium for installation. No Walkie Talkie Radio shall be changed after they are inspected.
- h. Walkie Talkie Radios shall be supplied and made functional 12 hours before the deadlines given in the tender document.
- i. Contractor shall ensure replacement of any faulty Walkie Talkie Radio within 2 hours of their being identified. Contractor may keep adequate reserves at site.
- j. Maintenance team of 3 engineers to be stationed at FZK Stadium 4 hours before the match commences and stays till match is over.
- k. Names of maintenance team to be given to DDCA 10 days before the match to prepare their accreditation cards.
- I. The security of Walkie Talkie shall be responsibility of the contractor. DDCA shall not be held responsible for any loss or damage to the Walkie Talkie supplied by the contractor.

- m. The numbers are tentative. Exact number shall be informed before the match. Payment shall be made on exact number only,.
- n. The Bidder shall ensure that all statutory compliances for its personnel are its responsibilities.
- O. The rates should include the transportation, installation and removal of the WALKIE TALKIE.
- p. All statutory taxes/fees of any kind shall be borne by the Bidder.

DDCA reserves the right to obtain feedback from the previous / present clients of the Bidder and also depute its team(s) to inspect the site(s) of their present contract(s) for on the spot first-hand information regarding the maintenance and other security related services provided by the Bidder. The decision of the DDCA in this regard will be final and binding on all bidders.
- 4. Material will be checked before using at site.
- 5. Eligibility Conditions:
 - a. The Bidder should be in the business of providing walkie-talkie services for a minimum period of three years as on date of submission of tender.
 - b. The Bidder shall ensure that the adequate technical support is available during the match.
- 6. Each page of the tender should be signed by authorized signatory.
- 7. The sealed envelope should be dropped in the Tender Box.
- 8. The bidder shall coordinate with all concerned authorities.
