- b. **STADIUM CHAIRS** shall be installed and made functional 1 week before the deadlines given in the tender document.
- c. **STADIUM CHAIRS** shall be installed to the satisfaction of DDCA.
- d. Contractor shall ensure replacement of any faulty CHAIR within 2 DAYS of their being identified. Contractor may keep adequate reserves at site. Contractor is required to maintain the chair for next six month after completion.
- e. Maintenance team of required engineers to be stationed at FSK Stadium during installation and commissioning of the Chairs.
- g. DDCA shall not be held responsible for any loss or damage to the **STADIUM CHAIRS** supplied by the Contractor.
- h. The Bidder shall ensure that all statutory compliances for its personnel are its responsibilities.

The rates should include the transportation, stacking and removal of the **STADIUM CHAIRS**. Also, before fixing of NEW CHAIRS, if any repairs or maintenance required on base of concrete should be done properly to get smooth finish, including three layers of industrial paint on floor.

All statutory taxes, fees, etc. of any kind shall be borne by the Bidder.

#### **INSTRUCTIONS TO THE BIDDER**

- 1. Please read the Terms & Conditions carefully before filling up the document.
- 2. Incomplete Documents will be rejected. It is in the interest of prospective Bidder that they may inspect the DDCA Premises /location prior to submission of their bids.
- 3. DDCA reserves the right to obtain feedback from the previous / present clients of the Bidder and also depute its team(s) to inspect the site(s) of their present contract(s) for on the spot first-hand information regarding the maintenance and other related services provided by the Bidder. The decision of the DDCA in this regard will be final and binding on all bidders.

#### 4. Eligibility Conditions:

- a. The Bidder should be in the field of construction or retrofitting of institutional / public infrastructures, for a minimum period of Five years as on date of submission of tender.
- b. The Bidder shall ensure that the adequate technical support is available.
- 5. Each page of the tender should be signed by authorized signatory.
- 6. Bidder shall have to submit a sample of the proposed chair to DDCA within 10 days from date of bid submission.
- 7. The sealed envelope should be dropped in the Tender Box.
- 8. The Bidder shall coordinate with all concerned authorities.
- 9. The necessary details / clarification if any can be obtained from the Manager Administrator & Infrastructure, DDCA Office between 11.30 AM to 3.00 PM on any working day.
- 10. All quotations / offers / Tenders should be in the format given at **Annexure** 'A' with signatures of authorized signatory and stamp of Company / Firm / Organization.
- 11. An Earnest Money Deposit (EMD) of Rs.20 lakh (Rupees Twenty Lakh Only) in the form of Bank Draft shall be submitted by all bidders. The Bank Draft will be favoring Delhi & District Cricket Association payable at New Delhi. All quotations submitted without EMD shall be rejected. EMD amount shall be refunded to unsuccessful Bidders within a week of opening the commercial bids. EMD shall be submitted by all bidders along with PAN No. / TAN No. / GST Number and I.D. Proof with Company / Organization / Firm's details of Registration, Memorandum & Articles, Partnership / Proprietorship details as the case maybe.
- 12. The payment for the services provided by the Bidder shall be made within 15 working days after the submission of the bills. Monthly bill can be submitted.

- 13. The quantity of chairs may vary (increase or decrease) by 20%, accordingly extra / less payment will be made.
- 14. The vendor / contractor must visit the stadium to check all items / requirements for tender.
- 15. DDCA reserves its right to award the work to multiple vendors at the L1 rate.
- 16. DDCA reserves its right to accept or reject any of the offers or cancel all offers and also modify conditions of effect any other change in items, terms and conditions.
- 17.
