Special Conditions of Contract

1. Detailed scope of work is given in Annexure 'A'. Please note that the final requirements might have variation depending on the security requirements of BCCI/ ICC / Delhi Police/DDMA.
2. PA System shall be installed and made functional 24 hours before the deadlines given in the tender document.
3. PA System shall be installed to the satisfaction of DCP (Central), Delhi Police. A certificate of satisfactory installation shall be obtained from Delhi Police and submitted to DDCA Security Department 24 hours before the commencement of match.
4. Contractor shall ensure replacement of any faulty speakers or systems within 2 hours of their being identified. Contractor may keep adequate reserves at site.
5. Maintenance team of 4 engineers to be stationed at FZK Stadium 12 hours before the match commences and stays till match is over.
6. Names of maintenance team to be given to DDCA 10 days before the match to prepare their accreditation cards.
7. The Contactor shall remove all the PA System within 48 hours of the match being over and store them in stadium as per directions of DDCA Security Department.
8. The security of PA System shall be responsibility of the contractor. DDCA shall not be held responsible for any loss or damage to the PA System supplied by the Contractor.

9. The Bidder shall ensure that all statutory compliances for its personnel are its responsibilities.
10. The rates should include the transportation, stacking and removal of the PA System.
11. All statutory taxes / fees of any kind shall be borne by the Bidder.

Instruction to the Bidder

1. Please read the Terms & Conditions carefully before filling up the document.
2. Incomplete Documents will be rejected. It is in the interest of prospective Bidder that they may inspect the DDCA Premises / location.
3. DDCA reserves the right to obtain feedback from the previous / present clients of the Bidder and also depute its team(s) to inspect the site(s) of their present contract(s) for on the spot first-hand information regarding the maintenance and other security related services provided by the Bidder. The decision of the DDCA in this regard will be final and binding on all bidders.
4. Eligibility Conditions:
 - a. The Bidder should be in the business of providing P.A. System services for minimum period of three years as on date of submission of tender.
 - b. The Bidder shall ensure that the adequate technical support is available during the match.
5. Each page of the tender should be signed by authorized signatory.
6. The sealed envelope should be dropped in the Tender Box.
7. DDCA shall require PA System for Delhi Police and Delhi Traffic Police briefing.
8. The Bidder shall coordinate with all concerned authorities.
9. The necessary details / clarification if any can be obtained from the Tender Committee, DDCA Office between 11.30 AM to 5.00 PM on any working day.
10. All quotations / offers / Tenders should be on the firm given at Annexure 'X' with Company / Firms / Organization Stamp.
11. An Earnest Money Deposit (EMD) of 10% of quoted final cost in the form of Bank Draft shall be submitted by all bidders. The Bank Draft will be favouring Delhi & District Cricket Association payable at New Delhi. All quotations submitted without EMD shall be rejected. EMD amount shall be refunded to unsuccessful Bidders within a week of opening the commercial bids. EMD shall be submitted by all bidders along with PAN No. / TAN No. /Service Tax Number and I.D. Proof with Company / Organization / Firm's details of Registration, Memorandum & Articles, Partnership / Proprietorship details as the case may be.
12. The payment for the services provided by the Bidder shall be made within 45 working days after the submission of the bills after the match.
13. DDCA reserves its right to accept or reject any of the offers or cancel all offers and also modify conditions of effect any other change in items, terms and conditions.

Detailed Scope of Work

Supply, installation, and services of Public Address Systems on a rental and turnkey basis to include maintenance, removal, and transportation for the entire season:

(a) Around the Stadium:

- PA two-way reflex horns (loudspeaker) (2 x horns which will be operational with each gates & control room.
- Wire/wireless mic as per the requirement of Delhi Police, Delhi Traffic Police, DDMA, Delhi Fire Services, and various agencies – as and when required.
- PA power amplifiers – as per requirement
- PA audio consoles (12 channels) for control room – as per requirement.
- 2 Core flexible wire 1 mm – as per requirement

(b) Stand-alone PA system with battery, Delhi Police recorded CD and manpower required in the following areas only on match day:

- The maintenance/replacement of equipment, a team should be available at site during match days.
