9. All Vendors specific health trade & other license will be responsible to obtain the health trade license from MCD.
10. The Vendor may include any other item subject to the approval of DDCA.
11. The applicant should be in the business of providing Hospitality services for a minimum period of three years as on date of submission of tender. Preference will be given to bidders having experience of managing Food Court.
