2. Incomplete documents will be rejected. It is in the interest of applicants to inspect the proposed premises before submitting the bid.
3. DDCA reserves the right to obtain feedback from previous/present clients of the applicant and also depute its team(s) to inspect the site(s) under the current contract(s) for on-the-spot first-hand information regarding the maintenance and other Signages-related services provided by the applicant. The decision of the DDCA in this regard will be final and binding on all bidders.
4. The applicant should be in the business of providing Signages Services for a minimum period of two years as on the date of submission of the tender.
5. The service provider shall provide the services mentioned in Annexure-A to the satisfaction of DDCA.
6. All costs pertaining to placement, removal, printing, and designing of signages, including all transportation costs to and from the stadium, shall be borne by the service provider.
7. The rates may be quoted separately for wooden and metal frames.
8. The applicant shall ensure that all statutory compliances for its personnel are its own responsibility.
9. All statutory taxes/fees of any kind shall be borne by the applicant.

Instructions to the Bidders

1. Necessary details/clarifications, if any, can be obtained from the Tender Committee, DDCA Office between 11:30 AM to 5:00 PM on any working day.
2. All Quotations/Offer/Tenders should be submitted on the firm's letterhead as per Annexure 'X', duly stamped with the Company/Firm/Organization seal.
3. An Earnest Money Deposit (EMD) of 15,000/- in the form of a Bank Draft, shall be submitted by all bidders. The Bank Draft should be in favour of Delhi & District Cricket Association, payable at New Delhi. Quotations submitted without EMD shall be rejected.
 - EMD amount shall be refunded to unsuccessful bidders within a week of opening the commercial bids.
 - EMD must be submitted along with PAN No./TAN No./Service Tax Number, valid ID proof, and complete Company/Firm/Organization Registration details, including Memorandum & Articles, and Partnership/Proprietorship documents, as applicable.
4. Payment for the services provided by the bidder shall be made within 45 working days after submission of bills post completion of the match.
5. DDCA reserves the right to accept or reject any or all offers, cancel the tender entirely, or modify the terms and conditions without assigning any reason.
6. The envelope containing the quotation, SUPERSCRIBED with the name of the item, shall be addressed to the Tender Committee, Delhi & District Cricket Association, Arun Jaitley Stadium, Ferozeshah Kotla Grounds, New Delhi – 110002, and should be dropped in the designated box kept at the reception of DDCA during office hours (10:00 AM to 5:00 PM).
7. The quotation must reach the DDCA office by 28th January 2026 by 05:00 PM.
8. Incomplete quotations in any respect will be summarily rejected.
9. In the event another party is to be engaged as a supplier for the tender, this may only be done with the written consent of the authorized official of DDCA.
