## ORDER

Whereas, the Apex Council of the Delhi and District Cricket Association (DDCA/ Association) had resolved to organize a franchise-based league within the NCT of Delhi; AND

Whereas, the Apex Council had sought the approval/ permission of the BCCI to conduct the said league. The Board of Control for Cricket in India (BCCI) had granted its approval for the conduct of the league and accordingly DDCA has successfully organised Delhi Premiere League T-20 Season 1 and 2; AND

Now therefore, in exercise of the powers conferred upon the undersigned by the Apex Council of the Delhi and District Cricket Association, following subcommittees are hereby constituted for the purpose of conducting the Delhi Premiere League (DPL/ League) and shall exercise powers as enumerated thereunder:

### 1. Organizing Committee (Composition and quorum)

Any five members of the Apex Council	Member

A. The organizing committee shall be responsible for overseeing the organization and conduct of the Delhi Premiere League. It shall also be responsible for the following:

- i. To ensure availability of the basic infrastructure and arrangement for the conduct of the tournament.
- ii. To identify pool of participating players, franchisee/ team owners, team officials, Support staff and team managers, sponsors etc.
- iii. To comply with Advisory issued to the State Association for hosting Franchisee Based League from time to time.
- iv. To comply with the Conflict of Interest Rules as laid down in the Lodha Committee Recommendations and adopted by the Association.
- v. To comply with the BCCI rules and regulations as may be applicable.
- vi. To comply with the protocols to be followed regarding BCCI Anti Corruption Code and BCCI Players and Match Officials Area ("PMOA") Minimum Standards.

### 2. Governing Committee (Composition and quorum)

B. The Governing Committee shall be responsible for organization and conduct of the Delhi Premiere League and to lay down broad guidelines for day to day operation of the league. It shall also be responsible for the following:

- i. It shall lay down Standard Operating Procedure, Rules, Regulations and processes for the Delhi Premiere League including playing conditions, tournament rules, process for selecting pool of participating players, team officials. Support staff and team managers, sponsors etc.
- ii. It shall ensure compliance of Advisory issued to the State Association for hosting Franchisee Based League from time to time.
- iii. Ensure compliance of the Conflict of Interest Rules as laid down in the Lodha Committee Recommendations and adopted by the Association.
- iv. Ensure Compliance with the BCCI rules and regulations as may be applicable.
- v. Ensure Compliance of protocols to be followed regarding BCCI Anti Corruption Code and BCCI Players and Match Officials Area ("PMOA") Minimum Standards.
- vi. To maintain and adhere to the highest level of transparency, integrity and ethics in awards of contracts in connection with the Tournament.
- vii. Submit a report within two weeks from the conclusion of the Tournament evidencing complying with the terms and conditions of the Advisory issued by BCCI for hosting the league/ tournament.
