3. Objective

The Delhi Premier League is organizing its official Player Auction for the 2026 season.

Perfect Pitch Events and Sports Private Limited seeks to appoint a premium hospitality partner capable of providing venue infrastructure, catering services, accommodation facilities, and associated operational support required for the successful execution of the Player Auction.

The selected partner shall ensure seamless delivery of all hospitality, venue, technical and operational requirements in accordance with the specifications outlined in this tender document.

4. Scope of Work

The selected bidder shall provide venue, hospitality, accommodation and related infrastructure services for the Delhi Premier League Player Auction 2026.

The venue must be suitable for live event production capable of supporting high resolution video and audio transmission/telecast, television broadcast setups and custom auction layouts.

5. Technical & Infrastructure Requirements

The hotel must possess adequate infrastructure to support a live auction environment. The bidder shall provide:

- Dedicated high-speed internet connectivity
- Symmetrical upload and download bandwidth
- Sufficient electrical load for production equipment
- Dedicated DG backup support
- Production control room space
- Franchise owner holding areas
- VIP green rooms
- Secure access control
- Dedicated parking arrangements
- Operational support staff
- Facility for Audio Visual system

6. Eligibility Criteria

Interested bidders must satisfy the following minimum eligibility requirements:

- Must be a registered hotel operating within Delhi NCR.
- **Must be a minimum 5-Star category hotel.**
- Must possess all applicable statutory licenses and approvals.
- Must have experience in hosting corporate events, sports events, conferences, auctions, award ceremonies or similar large-scale events.
- **Must have previously hosted at least one event similar in nature and scale to the Player Auction described in this tender.**
- Must be capable of accommodating a minimum of 250 guests in a single venue.
- Must provide in-house hospitality and banquet services.
- Must not have been blacklisted by any Government Authority, PSU, Sports Body or Corporate Entity.
- **A single hotel, company or entity (including its group companies, sister concerns or commonly owned/managed properties) shall not be eligible to submit more than one bid against this tender. Submission of multiple bids by the same entity may lead to rejection of all such bids.**
