DDCA LEAGUE FOR THE CRICKET SEASON 2022-23 (40 OVERS A SIDE)

(A) Playing conditions

- 1) League shall be called DDCA League & shall be conducted by DDCA League & Tournament Committee appointed by Apex Council. All the matches shall be treated as association conducted matches in reference to BCCI.
- 2) The match official, venue & date for the matches shall be binding on all the clubs/institutions and shall not be altered unless otherwise decided by the concerned committee.
- 3) All teams should report 30 minutes prior to the scheduled time & must give names of playing eleven to match officials not later than 15 minutes before start of play.
- 4) A minimum of 8 players are required physically (while fielding only) to start a match otherwise match shall be awarded to other side.
- 5) If a team fails to report half an hour after the schedule time of match, umpire shall recommend a walk over.
- 6) BCCI guidelines & code of conduct is applicable to all teams, players & officials.
- 7) The League & Tournament Committee can change venue & dates in unavoidable and EXTREME circumstances and shall be binding to all.
- 8) No player shall be allowed to change his own Club/Institution during a season ONLY unless he gets a confirmed employment / stipend / sports contract and produce his appointment letter in front of concerned Committee / DDCA Administrator.

- 9) Any Club/Institution wishing to withdraw from the DDCA League / Tournament, either before or after commencement of the concern competition, shall intimate in writing to DDCA Administrator / League Organizing Committee. In these case points of the particular team shall not be consider in that particular group and the team will also be relegated to the lower group in the next year.
- 10) If any time any players/team official is found misbehaving directly or indirectly with the Umpires or any other match official he will cease his right to play/participate/ represent further in the season and strict disciplinary action shall be taken again the team.
- 11)It will be mandatory for the Captain to submit the Captain's Report on Umpire/match officials including scorer on the prescribed Performa immediately after completion of the match. Such report will uplift the Umpiring / scoring standard.
- 12) The League & Tournament Committee may provide different rules & regulations for different phases, if necessary.
- 13) All kind of protest must be submitted to match officials there & then only by Secretary or Captain of participating teams.
- 14)All clubs have to register only players who is born / studying / working (Job) in Delhi or else have been a banofide resident of Delhi till 1st Sept., 2021

15) Hours of play:-

a) October to February

09.30 AM – 12.30 PM (1st Session) 12.30 PM – 01.00 PM (Lunch break) 01.00 PM – 04.00 PM (Till finish)

b) March onwards

08.30 AM — 11.30 AM (1st Session) 11.30 AM — 12.00 Noon (Lunch break) 12.00 Noon — 03.30 PM (till finish)

- Minimum 15 overs shall constitute 40 overs match (4 min/over)
- Restriction on placement of fieldsman (As per new format of BCCI)
- Covering & Rolling of pitch is allowed wherever possible and provided by ground authorities.

16) Points Criteria for League matches:

Win/getting Walkover : 4 Points Washout/Tie/No Result : 2 Points each

Loss : 0

Conceding the match : Minus 2 points & COC*

In all matches the player will have to carry proof of Residence and when the name of players are given the player will show their residence proof to the Umpires / Scorers. Any player not showing the Residence proof will not be allowed to play DDCA League Matches. One of the following documents should be carried by the players Aadhar / Passport / School or Collage ID / Birth Certificate.
