

**ANNOUNCEMENT OF BIDDERS DECLARED QUALIFIED FOR
PARTICIPATION IN AUCTION**

The documents submitted by the bidders along with NIT were examined by the Legal Advisor and the Accounts Department with the assistance of the Company Secretary as per the directions of League & Deputy League Commissioner. Out of four bidders who have submitted their offers till the notified time, three were found qualified and one disqualified in respect of not fulfilling the eligibility criteria as per NIT issued on 19.06.2025 as under:

<p>Consortium of Alutech Panels Limited, E3 Edgeband Industries Private Limited & Softsecure Infotech Private Limited.</p>	<p>NOT QUALIFIED</p>	<p>On scrutiny of Documents, it transpires that the lead bidder i.e. M/s Alutech Panels Limited has not filed its duly Audited and Certified Balance sheets for the last 5 years in terms of Schedule 2 (Technical Bid Form) and specifically S.No. 3 (Financial Standing) of Part-E of Schedule-2 and S.No. 10 of Part-F (Checklist if Documents attached) of Schedule-2 of the NIT.</p> <p>It is also noticed that the Gross revenue of the lead bidder for the F.Y. 2020-21, 2021-22, 2022-23 has been shown as NIL. The same does not command confidence in the financial standing and the same is found unsatisfactory in terms of S.No. 3.3 of Clause IV (3) of the NIT read with S.No 3 of Part-E of Schedule-2.</p> <p>It is also noticed that the Principal Place of Business of M/s Alutech Panels Limited is not Delhi as the GST certificate issued is in Gautam Budh Nagar, Uttar Pradesh, there being no additional place of business indicated in the certificate.</p> <p>The undertaking in terms of Corrigendum and clarification dated</p>

As such the bid document is incomplete.</p> <p>Further, as per the information, the bidders are also in direct contravention of Clause (V) of Rule 38(1) of the conflict of interest provision of BCCI as well as clause of 39(1)(V) of the DDCA Conflict of Interest provision, for which a separate notice would be issued to establish the correctness of information from the bidder and to proceed as per the provision of NIT if need be so.</p>
