INSTRUCTIONS FOR APPLICANTS

1. Please upload your CV along with the Application Form clearly mentioning the post that you are applying for.
2. Since one may apply for more than one post kindly mention your order of preference for the Posts.
3. Appointment will be made based on the guidelines issued by the BCCI for the domestic season 2026-2027 OR any other institute from time to time.
4. All the appointments shall be governed by SOP's issued by the BCCI for the conduct of domestic season 2026-2027. The same shall also be subject to restrictions imposed/ guidelines issued by the respective state government to which the teams may be required to travel. The applicants are bound by the decision taken by CAC/DDCA in this regard.
5. Individuals elected shall further be required to follow protocols as laid down by BCCI/DDCA from time to time.
