**Elections for the post of Treasurer and four Directors of DDCA-  
Instructions/Appeal to Members**

1. Only members of the Company shall be entitled to attend and vote at the Extra Ordinary Meeting of the General Body. No voting by proxy shall be allowed;
2. Members shall be only allowed to attend and vote, on verification of their identity. The members shall bring their DDCA membership card and any other identification document such as Election Identity Card, Passport, PAN Card, Driving License, Aadhar Card, or similar document issued by a Govt. Agency. Even If any member does not have the membership card, one of the other documents mentioned above would be sufficient to verify the identity. Thus, it may be noted that production of one of the identification documents of a Govt. Agency mentioned above is mandatory for all members.
3. Relevant documents referred to in the accompanying notice are available for inspection by the members of the Company on all working days during business hours, upto the date of the meeting;
4. In case of any query, members are invited to visit the web site of the Company- [www.ddca.in](http://www.ddca.in);
5. Members may refer to peruse and may visit the "Final Electoral Roll" uploaded and available on the web site of the Company;
6. In view of the Covid-19 pandemic, there are restrictions already in place for gathering of people by law and/or through Government guidelines. The guidelines also mandate maintaining social distancing, wearing of masks and ensuring hand sanitization. All members are requested to follow these mandatory requirements.
7. In order to comply with the guidelines and to avoid overcrowding, voting for the posts of Treasurer and four Directors of DDCA have been scheduled over four days, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> and 8<sup>th</sup> November, 2020 from 11

AM to 5 PM. (For the post of President, since there is only one contesting candidate, he is deemed to be elected unopposed, and there is no need for poll for the post).

8. There will be six polling booths , all located in the Arun Jaitley Stadium, for facilitating voting without crowding and to help members to vote without having to wait for too long. Polling booth Nos .1 to 3 will be in the Canteen area adjacent to the Fitness Centre in the New Club House, and booth Nos. 4 to 6 will be set up in the Parking Area in the Stadium near Gate No.2. Entry for all 6 polling booths will only be through Gate No.2.
9. In order to ensure that the purpose of staggering of polls is achieved and to reduce inconvenience to the members, specific polling booths have been assigned to members. Chart showing the assignment of polling booths may please be seen in the Annexure. Members may come on ANY of the four days of polling, however, they would be required to go ONLY to the assigned booth.
10. At the first entry point which will be set up at about 200 meters from Gate No.2 at the main entry lane from Bahadur Shah Zafar Marg, TEMPERATURE scanning will be done for all members. If the temperature of any members is shown to be above the normal range, such member will not be allowed to enter that day. This is being done as per Government guidelines to prevent spread of Covid-19. After crossing the first entry point, members will pass through a Sanitisation tunnel and proceed towards Gate No.2. All members are requested to co-operate.
11. At the entrance outside Gate No.2, six assistance counters will be set up to assist the members and to guide them to the booth concerned. Once the temperature scanning is done and the member is inside the first entry point, he/she will go to the counter outside Gate No.2. Members will be guided to their counter as per the chart shown in the Annexure. At this counter, after identification of the members, they will be given a slip mentioning their polling booth number and their serial number in the electoral roll. Members are requested to keep it with them and hand over the same to the polling official at their assigned polling booth.
12. In the polling booth also, the members will be required to show the ID document issued by Govt Agency as mentioned in para 2 above and their membership card (except for those who do not have the membership card). Once identity is established, the members shall be required to


